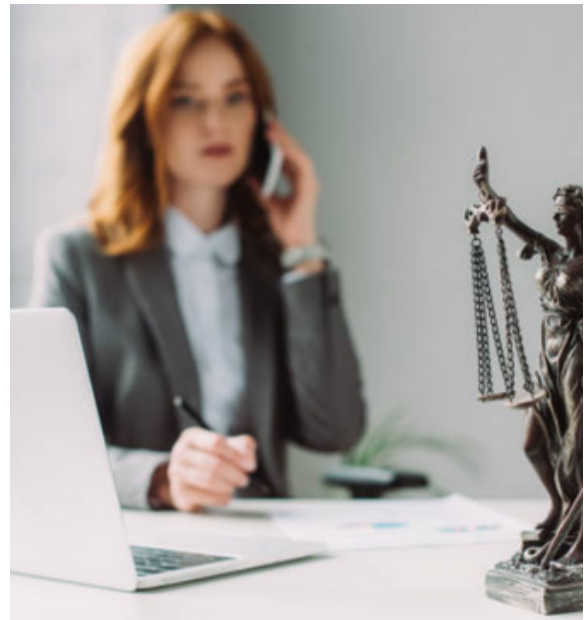


## 1 POTENTIAL CLIENT INTAKE
