# OUR PROCESS



## 1 CONTACT THE FIRM

Contact the Firm either by phone or online form to provide your name, contact information, and a brief description of the matter.

## 2 INITIAL FIRM INTAKE

The Intake Specialist and Client Coordinator will first conduct a conflict check. If no conflict is found, they will then schedule a Discovery Call with our Discovery Call Coordinator.



## 3 DISCOVERY CALL

You will speak with our Discovery Call Coordinator during a 30–40 minute conversation. The purpose of the call is to:

- Learn more about your situation
- Understand the urgency of your needs
- Explain our intake and case assessment process
- Determine whether your matter aligns with our services
- No legal advice will be provided during this call

## 4 RETAINING THE FIRM

If our firm can assist you, the Discovery Call Coordinator will guide you through the next steps—whether it's formally retaining the Firm or scheduling a paid Strategy Session with an attorney. Our hourly rate ranges from \$485 to \$750, depending on the complexity of the case.

# RETAINER & FEES



## RETAINER INFORMATION

At RLF Family Law, we believe in transparency from the very first step.

The **initial retainer fee serves as an advance deposit**, enabling our team to begin representation promptly and dedicate the time, preparation, and resources necessary to move your matter forward with precision and care.

## RETAINER COSTS

Retainer fees amount varies based on the complexity and scope of each matter. An average retainer fee for a contested case is **between \$5,000 - \$15,000+**



## RETAINER REPLENISHMENT

To ensure uninterrupted representation, you will be asked to **replenish your retainer** once the balance reaches a designated threshold. This process allows your case to progress seamlessly and ensures that all ongoing work remains properly funded.

Our firm:

- **Bills on a bi-monthly basis**
- Provide detailed invoices outlining:
  - The specific work performed
  - The time dedicated to your matter
  - Your current account balance

## HOURLY RATES

Our firm operates on an **hourly billing model** that provides clients with a clear understanding of how their resources are allocated and what work is being performed. This structure allows billing to accurately reflect the time and effort devoted to each stage of your case.

Hourly rates vary depending on the professional's position - from **\$225.00 for a Legal Assistant to \$750.00 for a Senior Attorney**.
